

Singer Capital Markets – Cookie Notice

Purpose

This Cookie Notice explains how we use cookies on the Singer Capital Markets website (<https://www.singercm.com>) and any marketing communications. Please ensure you take your time to read and understand this notice. This should be read in conjunction with our Privacy Notice.

What are cookies?

Cookies are small text files containing small amounts of information which are placed onto your device such as your computer, smartphone or other electronic device when you visit a website, provided your browser settings allow it. Many cookies are necessary to enable core functionality of websites to work. Cookies are widely used by websites to enable them to function properly and to improve the user experience.

How do we use Cookies?

Generally, our cookies perform one of three different functions:

1. Essential Cookies: Some cookies are essential for the operation of our website. For example, some cookies allow us to identify customers and ensure they can access any customer only pages. If a subscriber opts to disable these cookies, the user will not be able to access all of the content that they are entitled to.

2. Performance cookies: We utilise other cookies to analyse how our visitors use our website and to monitor website performance. This allows us to provide a high quality experience by customising our offering and quickly identifying and fixing any issues that arise. For example, we might use performance cookies to keep track of which pages are most popular, which method of linking between pages is most effective, and to determine why some pages are receiving error messages. We might also use these cookies to highlight articles or site services that we think will be of interest to you based on your usage of the website.

3. Functionality cookies: We use functionality cookies to allow us to remember your preferences (such as your username, language or the region you are in) and provide enhanced features. These cookies can also be used to remember changes you have made to text size, font and other parts of web pages that you can customise. They may also be used to provide services you have requested, such as watching a video.

Please be aware that applications you use on your browser may place cookies on your device (e.g. when signed into your Google Account when using Chrome). When visiting our website, if you follow any links, it may link you to a website not operated by us with cookies not operated by us.

By using our website you consent to our use of cookies as updated from time to time and the cookies we use will be stored on your device. However, you can choose to disable cookies by modifying the settings in your browser. You can find out how to do this, and find more information on cookies at: www.allaboutcookies.org.
